- 12. Prices shall remain firm for the first 6 months of the contract period. Price changes and catalog updates will be allowed after the first 6 months; vendors are to submit their requests on their company letterhead, indicating the contract award number and specify the changes that they are requesting to be made to the contract. <u>Laminate</u> - Grade A offers high pressure laminates, Grade B offers 18 high pressure laminates. 99% VOC free adhesives. Recycled particle board with high pressure decorative T-mold available in 7 colors.

<u>Fabric Application</u> - Panel fabric is stretched and held taut with high pressure spline. Tackboards and flippers doors fabric Is applied using low VOC adhesives

Electrical - 8 wire, 3 circuit systems. UL Certified.

<u>Panels</u> - Panel cores are recycled Haworth Unigroup or places with Steelcore, Honycomb Accoustic Baffel and fiberglass Insulation covered in new fabrics.

Lights - Newly manufactured, powder coated finish and UL certified.

Storage (overhead, cabinets) - File cabinets and pedestals are newly manufactured and powder coated. Shelf pans are new or remanufactured particle board painted and trimmed in high pressure T-mold.

All product finishes are prepared for the application of new fabric, laminate or paint per original manufacturers standards NBS uses only new plastic laminate to adhered to surface within industry approved adhesive

<u>Fabric application</u> - new fabric is cut to size and stretched by pneumatic upholstery equipment for quality application. This provided consistency with original manufacturer and is preferable to stretching by hand

Electrical - only new UL approved electrical is installed in NBS panels

<u>Panels</u> - NBS will use new or existing panel blanks, depending on size and quantity required. Existing panels' blanks will be stripped of existing fabric. The surface will be sanded to prepare surface for application of fabric or laminate, per approved order

<u>Lights</u> - NBS uses only new task lights, features light deferred lens for proper work surface lighting and a high performance ballast for efficiency

<u>Storage - (overhead, cabinets)</u> NBS will provide new and existing components depending on specification. Metal will be prepared and painted, bearings and glides inspected and replaced as needed.
