EXPLANATIONS:

Award of this contract will enable ESC Region 19 Allied States Cooperative members and its various programs to establish a contract with vendor for credit card and related services for procurements that must comply with the new Federal EDGAR requirements when federal funds are being utilized. The evaluation committee utilized a point system with weight factors of 45% product offerings/user systems, 30% references, 25% pricing structure. BBVA submitted a competitive solicitation but had a very small service area while the recommended vendor's intent was to access all 50 states on a national basis. Heartland Payment Systems, LLC dba Heartland School Solutions was also not awarded as their services did not meet scope of work.
