EXPLANATIONS:

Award of this contract will enable San Elizario ISD to procure waste disposal services for existing locations and any new locations it may require during the contract term. Administration from San Elizario ISD has expressed concerns over service in the past from the secondary vendor, therefore a recommendation is being made based on overall quality and past performance as well as pricing to award to the referenced vendor. Additionally, Heist Disposal agreed through the negotiation process to drop their price on special request pickups over and above the normal schedules from \$45 to \$30. This service is seldom required. Overall total costs of this contract were calculated over a 12 month period based on monthly pricing originally submitted.

1. All dumpsters must have slant-tops with plastic lids.
2. All pick-ups on selected days will be scheduled no later than 10 am.
3. Additional or emergency pick-ups, response time will be within (2) two hours.
4. Dumpsters that need exchange or replacements will be scheduled within 24 hours.
5. All dumpsters must have drain plugs as required by the City/County Health Dept.
6. The awarded vendor agrees to clean and exchange the Food Service Containers when requested.
7. Vendor will provide pricing for additional pickups when required during the contract term.
8. The district reserves the option to renew this contract for an additional period(s) if service is satisfactory, escalation does not exceed five (5) percent per year and renewal is agreed in writing by both parties.
9. Any changes to schedule and/or additional pick-ups will be authorized by the Facilities Director, Mr. George Luevano at 872-3939
10. Reference Contract must provide the following information for (3) major Accounts serviced in the El Paso area;
 - Name of business
 - Location and address of business
 - Contact person at the business including phone number
 - Estimated annual amount of contract.
11. Award basis will be 90% pricing and 10% references and past performance.
12. During the contract term, vendor must agree to prorate pricing for any service changes that may be requested due to decreases in pickups and/or decreases in the number of containers including reductions in pickup times during summer and vacation periods when attendance warrants, including addition of any new site locations during the contract.
13. Any fees associated with administration of this contract must be disclosed at the time proposals are submitted.
