Special Conditions

1. This solicitation is to purchase and maintain vehicles. Brands are specific and alternates should not be listed. Additional manufacturers may be proposed under the line item notating other manufacturers.
2. Vendors must be authorized to sell, install and service the manufacturer that is submitted. A manufacturer authorization letter must be uploaded under the vendor attachment section notating the ability to sell as well as the restrictions for selling and servicing by location.
3. Vendors must have a Franchise Motor Vehicle Dealer Certificate from the Texas Department of

Motor Vehicles or another state equivalent if proposing to sell vehicles outside of Texas.

4. Vendors MUST be a dealership authorized to sell new vehicles and provide service in order to be considered for award. This solicitation is not for service only.

5. Base price proposed should include all fees except delivery fees (destination fees from manufacturer, inspection fee, etc.). This does NOT include the administrative fee. Base price should NOT include any optional equipment.

6. Optional equipment shall be listed on a separate price list and uploaded under the vendor attachment section of the electronic bidding system. Vendor must bid on the percent discount from optional equipment line for the manufacturer being proposed.

7. The administrative fee for this solicitation will be limited to \$400 per purchase order for all vehicle purchases and 2% per purchase order for all services performed after vehicle purchase.
