Children's Home Therapy Specialists dba Villa Children's Therapy was awarded a recent contract and therefore removed from this bid award. Autism & Behavioral Pediatric Clinic, Gus Carrera, Insight Photo, and Live&Love LLC (Jesus Guerrero) were terminated for failure to pay administrative fees and/or report sales, per the terms of the bid. D.R. Wilkes Consulting is no longer in business and requested to be removed from award. A&F Water Solutions LLC, Alygn Solutions, Boost Human LLC, EAC Management LLC, Embrace Consulting, and Messenger Charters LLC were removed from award for failure to submit insurance as per the bid requirements.
