Attainment Company, Inc., Boom Learning (Omega Labs Inc.), Elementari, LLC (Nicole April Kang) and Final Graphic, LLC did not meet the scope of work and were not considered. Ion Wave Technologies, Inc. (SpedTrack), PowerSchool Group LLC (Severin Intermediate Holdings LLC), and Public Consulting Group, Inc. were removed from award; failure to submit a Certificate of Insurance per bid requirements. SuccessEd, LLC was removed from award, vendor did not wish to extend contract for an additional year.
