Evaluation and award recommendation were based on 70% pricing and services/qualifications and 30% references. Ascend Education (KMB of Shreveport, L.L.C.), Benchmark Education Company, LLC, Brainchild (Brainchild Unlimited, Inc.), DrumFIT USA Corporation, Escape Rooms Teaching Classrooms (Get Out Escape Room), Lectorum Publications, Inc., MaxiAids, Inc., Rally! Education, Russell's Educational Consulting (Hazel Russell), Seidlitz Education, Southern Science Supply (Carol Espensen), Superior Text LLC, Teachers Discovery Inc (American Eagle Inc.), TeachTown (Jigsaw Learning LLC), TestOut Corporation, Troxell Communications, Inc., White Rock Cybersecurity (White Rock Security Group, LLC), and Wood Etc. Co. submitted a proposal however were not considered; vendors are already awarded on an existing contract. The Haberman Educational Foundation, Inc submitted a proposal however was not considered; vendor does not meet the scope of work. The awarded vendors' pricing and information can be found on the Award Detail spreadsheet. Rhithm was removed from award as they are no longer in business. Corwin Press and World Book, Inc. were terminated for failure to pay administrative fees and/or report sales, per the terms of the bid. Accelerate Learning Inc., Creative Mathematics, Learning Without Tears (No Tears Learning), MindRise Learning, and Really Great Reading Company, LLC. were awarded a recent contract and therefore removed from this bid award.
