American Program Bureau, Inc. submitted a proposal however was not considered; vendor did not agree to the solicitation terms and conditions. Benchmark Education Company, LLC, Corwin Press, Express Employment Professionals East El Paso (AM Innovations, Corp.), Insights El Paso

Science Center, Lowman Consulting LLC, New Teacher Center, Practical Parent Education, Sirius Education Solutions (Sirius Education Solutions LLC), Student's Eat Safely (Emily M. Homer), The DBQ Project (The DBQ Company), and True North Consulting Group, LLC submitted a proposal however were not considered; vendors are already awarded on an existing contract. JSR Construction & Remodeling LLC (Jesus Rodriguez), Pyrocom System Inc. (PyroCom Systems Inc.), and Sparrow Company (Sparrow Company LLC) submitted a proposal however were not considered; vendors do not meet the scope of work for this solicitation. EKHP Consulting, LLC was removed from award due to being awarded on a contract that was a better fit for the services they provide. Rhithm was removed from award as they are no longer in business. Conscious Discipline (Loving Guidance, Inc.), Engage! Learning Inc.
