Evaluation and award recommendation were based on 70% pricing and services/qualifications and 30% references. The awarded vendors' pricing and information can be found on the Award Detail spreadsheet. Aloe Software Group LLC, Be Glad LLC, Christ Chavez, EDU Specialist, LLC, Empowering Writers, LLC, Express Employment Professionals East El Paso (AM Innovations, Corp.), Hagar Restaurant Equipment Service, and Manges Consulting, LLC submitted a proposal however were not considered; vendors are already awarded on an existing contract. Check My Universe, LLC, Nine Degrees

Architecture + Design, Pyrocom System Inc. (PyroCom Systems Inc.) and RO IT Solutions (RO IT Solutions, LLC) submitted a proposal however were not considered; vendors do not meet the scope of work. Paula Kluth Consulting submitted a proposal however was not considered; vendor's proposed deviations were not acceptable. Newsela, Inc. withdrew their submittal. Adjuvant Consulting, Inc. and Insight Global LLC (IG True Grit Parent Holdings, Inc.) were removed from award due to being awarded on a contract that was a better fit for the services they provide. Corinna Villar Cole was removed from award; vendor was delinquent on reporting and/or administrative fee payment. Zove1, LLC (John C. Harre Jr), Applied Practice (Propel Education Strategies, Inc.), Dual Language Education of New Mexico, Education Elements, Josh Shipp Productions LLC (Top Youth Speakers), KAMICO Instructional Media Inc., MindRise Learning, National Science Teachers Association-NSTA, Responsive Learning LP, Rev it Up! Consulting Group (Rev it Up! Consulting Group LLC), and Richards Lindsay & Martin, LLP were awarded a recent contract and therefore removed from this bid award. Candor Consulting and Diagnostics LLC, El Paso Child Guidance Center, Eunice Martinez LPC-S/LBSW PLLC, Growth Counseling Center (Rueda) (Brenda Rueda), and Rio Del Sol (Adante Ramon Avalos) were awarded a recent contract and therefore removed from this bid award. BloomBoard Inc., Center for Student Achievement Solutions, Dawn P. Flanagan Ph.D./P.A., Dr. Mike! (Mike Longoria), FEV Tutor (Focus Care, Inc.), Jengo Facilities LLC, Kickboard, Inc., LuAnn Escobar, Wave Nine Inc, and Weller Communications were removed from award for failure to submit insurance as per the bid requirements. Cady Studios, LLC was awarded a recent contract and therefore removed from this bid award. 240 Tutoring Inc. (Scott Rozell), HighScope Educational Research Foundation, IXL Learning Inc., Rethink Autism Inc., Stetson and Associates Inc., and Studies Weekly, Inc. (American Legacy Publishing) were awarded a recent contract and therefore removed from this bid award. Sheri Pellicotte was removed from award for failure to submit insurance as per the bid terms. Young Rembrandts (Creart INC), and Display Services Inc were terminated for failure to pay administrative fees and/or report sales, per the terms of the bid. Bilinguistics, Inc. was awarded a recent consulting contract and therefore removed from this bid award. Citygovapp Inc was awarded a recent contract and therefore removed from this bid award. A+ Metal Enterprises Inc (A+ Metal Enterprises, Inc), Dual Language de Tejas (Olivia Hernandez), Pinova Dental (North Mesa Dental), and Trans America Protection Corp were terminated for failure to pay administrative fees and/or report sales, per the terms of the bid.
