Evaluation and award recommendation were based on 70% pricing and services/qualifications and 30% references. The awarded vendors' pricing and information can be found on the Award Detail spreadsheet. Adventures in Learning/AIL Products (Gregory Dale Laufer), Anissa Moore dba Anissa Moore Educational Consulting (Anissa Moore), Be Glad LLC, Empowering Writers LLC, Express Employment Professionals East El Paso (AM Innovations Corp.) (Express Services Inc.), LuAnn Escobar, and Pearlized Mathematics Consulting LLC submitted a proposal however were not considered; vendors are already awarded on an existing contract. AmeriChoice Construction LLC, Asentex, Inc, Aspire HR Inc., Compu-Cel (Personal Computer Technologies, Inc.), Countryman & Co., Full Turn Interior Solutions, Inventive Patriots LLC, Longhorn Electrical Services Inc., Mass Interact, and Strivven Media LC submitted a proposal however were not considered; vendors do not meet the scope of work. Corwin Press and Forde-Ferrier LLC were terminated for failure to pay administrative fees and/or report sales, per the terms of the bid.
