Award of this solicitation will enable ESC Region 19 - Allied States Cooperative (ASC) to establish a contract with vendor(s) for Athletic Equipment, Supplies, Uniforms and Related for those procurements made with federal, state or local funds. Evaluation and award recommendation were based on 70% pricing and services/qualifications and 30% references. The awarded vendors' pricing and information can be found on the

Award Detail spreadsheet. Alert Services, Inc. submitted a proposal however was not considered; vendor is already awarded on an existing contract, and they do not meet the scope of work. Speed Stacks Inc and The Scholastic Network Partners LLC submitted a proposal however were not considered; vendors do not meet the scope of work. Bay Promo LLC is permanently closed and therefore removed from award. Premier Uniforms and Tactical Gear (AH Enterprises Inc.) was terminated for failure to pay administrative fees and/or report sales, per the terms of the bid. Richey Athletics (Richey & Son Inc.) and Sky High Pole Vault LLC (Mario Alberto Loya Jr) were removed from award for failure to submit insurance as per the bid terms.
