Award of this solicitation will enable ESC Region 19 - Allied States Cooperative (ASC) to establish a contract with vendor(s) for Printing Services, Promotional Supplies and Related for those procurements made with federal, state or local funds. Evaluation and award recommendation were based on 70% pricing and services/qualifications and 30% references. Calfee Specialties (Blue Ribbon Promotions), Corporate Connection (EP Promo Wear), and E & L Graphics LLC dba El Paso Mail & Print Services submitted a proposal however were not considered; vendors are already awarded on an existing contract. Texas Custom Embroidery (Hector Medina) was removed from award for failure to submit insurance as per the bid requirements. Texas Custom Embroidery (Hector Medina) submitted the required insurance, and their bid award has been reinstated. Premier Uniforms and Tactical Gear (AH Enterprises Inc.) was terminated for failure to pay administrative fees and/or report sales, per the terms of the bid. T-Shirts Plus (Jose Aguirre) was removed from award for failure to submit insurance per the bid requirements. The awarded vendors' pricing and information can be found on
