Evaluation and award recommendation were based on 70% pricing and services/qualifications and 30% references. The awarded vendors' pricing and information can be found on the Award Detail spreadsheet. Entry Shield Security LLC, Nodo Tech LLC, Premier Uniforms and Tactical Gear (AH Enterprises Inc.) and Work Wear Safety Shoes (Northern Imports) submitted a proposal however were not considered; vendors do not meet the scope of work. Executive Medical Protection Services (Reyes Health and Safety Services LLC) (Edwin E. Reyes dba Reyes Medical and Safety Services), and Range USA (Topco America, LLC) (Range USA Ecommerce Store LLC) were terminated for failure to pay administrative fees and/or report sales, per the terms of the bid. Securitas Security Services USA, Inc. was removed from award for failure to submit insurance as per the bid terms.
