Award of this solicitation will enable ESC Region 19 - Allied States Cooperative (ASC) to establish a contract with vendor(s) for Classroom Curriculum, Supplies, Equipment and Related (Supplemental) for those procurements made with federal, state or local funds. Evaluation and award recommendation were based on 70% pricing and 30% references. Attainment Company, Inc., El Paso Office Products, FEV Tutor Inc. (Focus Care, Inc.), Hameray Publishing Group, Inc., Hatch, Inc., HighScope Educational Research Foundation, Hope Rising SEL (Forming Lives, Inc.), Kamico Instructional Media, Inc., MaxiAids, Inc., Medicaleshop Inc., Nearpod Inc., Perma-Bond Books (Hertzberg-New Method, Inc.), Russell's Educational Consulting (Hazel Russell), Shmoop University, Inc., Superior Text LLC, Sweet Pipes (BRBM Publishing LLC), Teachers Discovery Inc (American Eagle Inc.), and Youthlight, Inc. submitted a proposal however were not considered; vendors are already awarded on an existing contract. Language Acquisition Research Foundation of Texas, and Otter Graphics Inc. submitted a proposal however were not considered; vendors do not meet the scope of work. Lab Resources, Inc. withdrew their submittal. Seesaw Learning, Inc. submitted a proposal, however was not considered; vendor's proposed deviations were not acceptable. North Star Editions Inc., Social Studies School Service, and Western Capital Services LLC were removed from award for failure to submit insurance as per the bid requirements. Back 2 School Texas, L.L.C. was terminated for failure to pay administrative fees and/or report sales, per the terms of the bid. Avant Assessment (Avant Assessment, LLC), Carnegie Learning, Inc., Children's Plus, Inc., Ori Learning (SpecialNeedsWare, Inc), Pacific Learning, Inc., ProSolve LLC, Rainbow Book Company (Rainbow Books Inc.), Real OT Solutions, Inc., TAG2: The Art of Continuous Growth, and UWorld, LLC were awarded a recent contract and therefore removed from this bid award.
