**EXPLANATIONS:**

Award of this solicitation will enable ESC Region 19 - Allied States Cooperative (ASC) to establish a contract with vendor(s) for Guidance and Counseling, Mental Health Support, Intervention, and Therapy Services for those procurements made with federal, state or local funds. Evaluation and award recommendation were based on 70% pricing and 30% references. The awarded vendors' pricing and information can be found on the Award Detail spreadsheet. Care Behavioral Health LLC, Garro Behavior Consulting (Joan Marie Rickerl Garro), and Real OT Solutions, Inc. submitted a proposal however were not considered; vendors do not meet the scope of work. Pacific Learning submitted a "No Bid" response and does not meet the scope of work. Gaggle.Net Inc. withdrew their submittal. Assessment Intervention Management LLC and The Portal-CI (Mandy S. Lopez) were removed from award for failure to submit insurance as per the bid requirements. Rio Del Sol (Adante Ramon Avalos) requested to have his contract terminated; award summary has been amended accordingly. eLuma LLC, Leken Translations (Leken Translations LLC), and Mind Solutions Health Services were removed from award for failure to submit insurance as per the bid terms. Villa Children's Therapy (Children's Home Therapy Specialists) is no longer in business and did not want to extend and was therefore removed from award. Maria de Jesus Ortiz and Translation & Interpretation Network LLC. were removed from award for failure to report/pay administrative fees as per bid requirements. Vitanya Brain Performance Center (Strickland Health Products, LLC) was removed from award at their request.
