Evaluation and award recommendation were based on 70% pricing and 30% references. 1<sup>st</sup> Class Educator, LLC, 240 Tutoring, Inc., and Rev it Up! Consulting Group (Rev it Up! Consulting Group, LLC) submitted a proposal however were not considered; vendors are already awarded on an existing contract. Houston Education Leadership Partners (Houston Education Leadership Partners, LLC), and Stuttering Therapy Services and Seminars, PLLC (Nina Ann Reardon Reeves) submitted a proposal however were not considered; vendors do not meet the scope of work. Broaddus & Associates removed from award; vendor does not meet scope of work. Lateralus Group, LLC. was

removed from award for failure to submit insurance as per bid requirements. Educational Support Services (Deamer Ventures; Deamer Ventures LLC), Enterprise Risk Management (Guadalupe Rodriguez), and pepelwerk (pepelwerk llc) were removed from award for failure to submit insurance as per bid requirements.
