The awarded vendors' pricing and information can be found on the Award Detail spreadsheet. 240 Tutoring Inc., Barnes & Noble Booksellers Inc., BookNook Inc, Capturing Kids' Hearts (The Flippen Group, LLC), Condor Consulting Group LLC, EPS Operations LLC, eReflect Inc, HighScope Educational Research Foundation, Just Right Reader Inc., Learning Farm LLC, and Real OT Solutions Inc. submitted a proposal however were not considered; vendors are already awarded on an existing consulting contract. AeroFrohne (Derrick Anthony Frohne), BNX Financial Solutions LLC DBA BNX Business Advisors (Yara Banks), Rol-N Enterprise Inc., and Sun City Massage & Wellness (Sun City Massage, LLC) submitted a proposal however were not considered; vendors do not meet the scope of work. Candor Consulting and Diagnostics LLC, Cristina Devereaux Ramirez, and Ztastic Solutions LLC submitted a "No Bid" response. Bio Corporation (Bio Company Inc) withdrew their submittal. Risas y Sonrisas, LLC (Leticia Smith) was removed from award for failure to submit insurance as per the bid terms. Miguel Briones Writes dba Know Culture (Miguel A. Briones) was removed from award for failure to submit insurance as per the bid terms.
