EXPLANATIONS:

Award of this contract will enable ESC Region 19 and its purchasing cooperative members to purchase turnkey financial and/or student systems software programs to replace their dated older software systems. This RFP was processed at the request of El Paso ISD, Clint ISD, Fabens ISD, San Elizario ISD, and Region 19 Business Services. Specifications utilized were developed over a number of years with input from numerous entities. The new systems are web based applications that have the ability to run on single servers if necessary with detailed interface capabilities for elimination of dual entry and other problems common to older systems. In short, hardware requirements will be dramatically reduced over older systems running on mini computers. Award of this cooperative contract will also enable other schools in Texas who wish to join the Region 19 Purchasing Cooperative to utilize this contract without going through a competitive solicitation, thereby resulting in substantial time and savings to those entities. While pricing is extremely important, the evaluation committee agreed to utilize the National Association of Purchasing Manager's selection model to find the best overall value for entities wishing to identify, purchase, and implement either a financial or combination financial and student system that would comply with Texas stated mandated PEIMS requirements. After numerous presentations, conference calls, and meetings, the following criteria which was provided to all potential vendors in advance was applied; 1) Features & Functions was assigned 25%, 2) Support & Service was assigned 20%, 3) Ease of Use/ Implementation was assigned 15%, 4) Ability to interface & integrate was assigned 10%, 5) Ability to expand the system was assigned 10%, 6) Costs was assigned 10%, and 7) Software Publisher's track record was assigned 10% for total weight factor of 100%. Additionally, the company recommended for award has also agreed to provide the source code for all programming applications which would enable any district with a programming staff to make modifications and customization when required.

Proposals from Sungard/Bi-Tech and Tyler Technologies were not considered for the finance module because they exceeded budgeted funds. NCS Pearson and Campus Ware only submitted student systems. The four school districts evaluating the proposals determined it would be in their best interest not to separate the finance and student systems, therefore these two proposals were not considered. The proposals considered by the evaluation committee included proposals by Prologic, Sungard Pentamation, Weidenhammer Systems, and Skyward Incorporated.

EXPLANATIONS:

All final negotiations with Prologic Technology Systems prior to recommending a final award were agreed to in writing by the company. Some of the agreements reached include but are not limited to development of a KRONOS time and attendance interface module to facilitate any existing KRONOS clients, an increase of personnel in the El Paso market to insure successful implementations with area school districts and Region 19 through training and support, agreement to release the source code to El Paso ISD or any other entities with a staff of program developers, agreement to pay as the program is implemented, and agreement to work with other potential Prologic clients through the ESC Region 19 Purchasing Cooperative when applicable.
