Evaluation and award recommendation were based on 70% pricing and 30% references. The awarded vendors' pricing and information can be found on the Award Detail spreadsheet. 240 Tutoring Inc., Aloe Software Group LLC, Amira Learning Inc., Barnes & Noble Booksellers Inc., Betters-Bubon Consulting, Character Development and Leadership LLC, HeyTutor Inc., HighScope Educational Research Foundation, Learning Farm LLC, Saddleback Educational Inc., The Reading Warehouse Inc, and Top Youth Speakers (Josh Shipp Productions LLC) submitted a proposal however were not considered, vendors are already awarded on an existing consulting contract. Candor Consulting and Diagnostics LLC submitted a "No Bid" response. Century Resources LLC, Document Doctors LLC, eLuma LLC, H2A Consulting, James Lopez (Quality Commercial Services), and Tuatara Consulting Inc. submitted a proposal, however, were not considered, vendors do not meet the scope of work. Khan Academy withdrew their submittal. Milton Durango Communications Consulting submitted a proposal, however, was not considered, vendor did not meet the bid requirements. Academic Learning Company dba Velazquez Press was removed from award for failure to submit insurance as per the bid terms.
