Accelerate Learning Inc., Bluum USA Inc., eReflect Inc, Hameray Publishing Group Inc., HighScope Educational Research Foundation, Really Great Reading Company LLC, and Rethink Autism Inc. submitted a proposal however were not considered; vendors are already awarded on an existing consulting contract. Althouse Restore (Althouse Cleaning Inc.), PMCHAMELEONS (PMCHAMELEONS LLC), Progressive Pools LLC, Triple-S Janitorial Supplies (Third Gen LLC), and Upfront Solutions for Education submitted a proposal however were not considered; vendors do not meet the scope of work. Fallsway Equipment Co. LLC submitted a proposal however was not considered; vendor is already awarded on an existing contract that is a better fit. Bell 2 Bell Educator Supplies LLC and Cambridge University Press & Assessment (University of Cambridge) submitted a proposal however were not considered for failure to bring their account current.
