- 3 Evaluation and award recommendation will be based on 70% pricing and 30% of vendor's ability to provide services as specified rated by previous sales history.
- 4 The ESC Region 19 Purchasing Cooperative reserves the option to award in groups, award individually, or award all or none, or a combination of, whatever is determined to be in the best interest of the membership.
- 5 This specialty bid will be for deliveries as required during the period of August 2011 through August 2012.
- 6 Pricing will remain fixed for the first six (6) months with price increases or decreases accepted only after justification has been documented by the ESC Region 19 Purchasing Cooperative.
- 7 All purchase orders and invoicing will be directly with each district using this contract.
- 8 Deliveries will take place at any time during working hours except during breakfast and lunch serving times when staff is not available to verify and check in orders.
- 9 Deliveries will take place between 6:45 AM and 10:30 AM to the cafeterias.
- 10 Deliveries will take place two up to three days per week during the contract period.
- 11 Monthly menus for each campus will be provided to delivery personnel upon request.
- 12 Delivery vendor personnel will check with each cafeteria manager in person one day per week agreed upon mutually so that orders for the following week can be given to the vendor.
- 13 The awarded vendors will be responsible for coordinating with each agency utilizing this contract on any conditions regarding deliveries.
- 14 Any unacceptable product will be picked up the next business day after original delivery and replaced with acceptable product.
- 15 Any omitted product from a delivery will be delivered the next business day.
- 16 All product delivered will be sealed and free from leaks, and be kept at a temperature of 40 degrees Fahrenheit and be delivered in clean sanitary cases.
- 17 **CN labeling or product nutritional specification sheets to be provided with bids.**
- 18 Individual monthly statements will be sent for each campus the vendor has delivered to at the close of each month during the contract period.
- 19 Vendor will leave **two clear legible invoices** at each campus location upon each delivery showing the location, unit descriptions, and unit price as well as an invoice total.
- 20 Cafeteria delivery locations, contact personnel, phone numbers, and other specific information will be provided to awarded vendors upon award unless requested prior to bid submissions.
