- This contract will be tied to a fixed margin in cents over the weekly local EI Paso VALERO posted pricing released every Thursday and vendor will provide electronic copy of the BPN newsletter on Thursday of each week to directly to ESC Region 19 Purchasing Cooperative and any ESC Region 19 Purchasing Cooperative members who are utilizing this contract. The news letter weekly update must show the market price for the EI Paso Valero posted closing price to take effect the next day for seven days. All deliveries during the seven day period will be with the margins agreed to in the contract.
- 2. Currently, the ESC Region 19 Purchasing Cooperative has 125+ members in Texas, and the following local entities reside in the El Paso area:

- 3. This proposal will also require certified technicians in compliance with all Texas Railroad Commission legislation and regulations to perform any services that may arise at a designated hourly rate.
- 5. While the listed ESC Region 19 Purchasing Coop members currently have purchased and own all of their propane tanks, vendors should have the ability to sell and install propane tanks in compliance with all local, state, and federal requirements if the need arises during the contract period.
- 6. Awarded vendor agrees to make deliveries as propane is required even if deliveries are more than once per week. Some customers may elect "WILL CALL" as propane service is needed while others may elect "KEEP FULL" service for delivery to locations of ESC Region 19 Purchasing Coop members.
- 7. Additionally, propane buses will be going into service over the next year, hence a listing of refueling stations for propane is required.
- 8. The margin submitted will include all freight from the refinery to the storage facility, delivery of the product to the end user, and all overhead including billing, office personnel, delivery personnel, vehicle maintenance, compliance with state and federal regulations, etc.). No additional fees will be accessed to the end-user unless supplier has identified the fee, tax, or otherwise with their original proposal submittal.
- End-user ESC Region 19 Purchasing Cooperative members utilizing this contract will provide facility and tank information to the awarded vendor prior to placing orders so that vendor can determine whether or not bob-tail (approximately 2500 gallons per delivery) or transport service (approximately 9500 gallons per delivery) will be required.
