Award of this contract will enable Region 19 Purchasing Cooperative members to rent high speed duplicators monthly with all inclusive pricing for supplies required to produce copies. Administration is recommending Spectrum Imaging based on the requirements of the users of this contract. A proposal from Dahill provided one price for monthly rentals at a flat rate of \$267; however Spectrum Imaging qualified its proposal for monthly rentals to include tiered pricing starting from \$159 up to \$279 per month, with volume usage limits up to unlimited usage. Overage fees per copy were negligible at .0039 per copy when needed. Additionally, in reviewing current usage, 50% of users of this contract did not require unlimited volume. Additionally, it was determined that less than ½% of users on the previous contract had requirements for listed options; therefore options were not a major factor.
