#### **EXPLANATIONS:**

Award of this contract by the ESC Region 19 Board of Directors will enable ESC Region 19 and ESC Region 19 Head Start to utilize services as specified in the Request for Qualifications. Three (3) top architectural firms were interviewed by the committee. The following two (2) firms are being recommended for this contract to be utilized over the next five (5) years for new construction and renovations by ESC Region 19 and its programs. The committee utilized the original weight factors for the award recommendation; after interviewing each of the top three (3) firms. Mijares-Mora Architects is being recommended for the new parking facility structure at 6611 Boeing to work with the El Paso International Airport and the City of El Paso to enable ESC Region 19 to negotiate a new Smart Code Compliance structure along with a new 40-50 year land lease for the 6611 Boeing location. PhiloWilke Partnership is also being recommended as well to eliminate administration having to go back out for another solicitation in the event of changes. Both vendors would be utilized for future new construction, renovations, and other new building grants that may be approved over the next five (5) years. As per the Professional Services Act, rate structures can only be negotiated after the vendors have been awarded by the Board of Directors. ESC Region 19 administration will negotiate a rate structure based on current market conditions. In reaching out to other governments that have used these architects, administration believes the rate structures will be in line with El Paso's current rates for government architectural services. The rates will be provided at the next scheduled Board Meeting.
