Discovery Education Resources, LLC is awarded on a previous contract for the exact same items and pricing that were turned in with their proposal for this solicitation, and for that reason they were not considered. AnMar Enterprises Inc. dba Airport Printing Service, David's Apparel Inc., La Estrella, Rocks-Schoolwear, and Universal Graphics, Inc. have all been awarded on RFP #16-7198; therefore were not considered for award. Any vendor who took exception to standard shipping/handling being included with the catalog discount including this fee was not considered for award.
