Award of this contract will enable ESC Region 19 Allied States Cooperative to establish a contract with vendor(s) for maintenance, repair and operation, equipment, supplies and materials for those procurements that must comply with the new Federal EDGAR requirements when federal funds are being utilized. The evaluation committee utilized a point system with weight factors of 50% pricing, 25% selection/quality and 25% references. Bellomy Heating & Air, Inc. and V.M.P. Industrial Sales, Inc. were both not awarded as both companies already have contracts with ASC for the services they submitted for. Harrington Industrial Plastics failed to provide references, Mevacon, LLC did not provide any type of pricing and did not meet the necessary reference requirements. Sky Construction & Engineering, Inc. did not provide pricing per bid requirements. State Industrial Products, The Goodyear Tire & Rubber Company and Zarco Electronic Supply, Inc. also failed to meet the reference requirements. All awarded vendors' pricing can be accessed through their price links.
