SPECIAL CONDITIONS:

1. This RFP is for Audio, Video, Security and Low Voltage Equipment, Supplies and Installation by ESC Region 19 and ESC Region 19 ASC Coop members in El Paso and the surrounding area who are members of the ESC Region 19 Allied States Cooperative.
2. Each designated category will be awarded on an "item by item" basis; however the ESC reserves the option to award in categories when it has been determined to be in the best interest of ESC-Region 19 ASC clients.
3. Vendors need not respond to all categories to be considered for award.
4. Proposals received without proof of workers compensation, general liability, and professional legal liability will not be considered for award.
5. Local suppliers for JIT (just in time) pickup and delivery are encouraged to respond to this contact.
6. No submittals will be considered or evaluated for possible award unless wholesale price lists are submitted from either the company, manufacturer, or wholesale supplier.
7. Vendors responding to this proposal must agree to service any new ESC Region 19 Purchasing Cooperative members that join during the contract period, as long as the member is in good financial standing with the awarded vendor.
8. Vendor agrees to furnish copies of all invoices for materials to the client when invoices are submitted for jobs completed.
9. All tools, ladders, extensions, scissor lifts, and trade supply materials will be at vendors cost and will be included with invoices submitted for payment.
10. Any required permits will be the responsibility of the vendor and may invoice the client as a pass through cost only. Required licenses or permits should be provided, if known, at the time proposals are submitted.
11. Clients reserve the option to purchase their own materials to insure the quality of their choice.
12. Vendor agrees to have full crew working to expedite work and be willing to work after hours and on weekends to eliminate interruptions.
13. Any and all cleanup and removal from work site will be the responsibility of the awarded contractor.
14. All work performed under this contract will come with a one year warranty as to workmanship and functionality.
15. Awarded vendors will show the ability to procure, install, configure and certify elements of any associated Scope of Work, to include owner acceptance as well as adherence and continuance of all manufacturers' warranty.
16. Bids to include equipment and installation by manufacturer / factory certified installer, end user training and items which contain electrical power distribution (i.e. UPS Back Up, Power Conditioners and Power Supplies) to include installation by a licensed electrician.
17. Awarded vendors will be responsible for TurnKey purchase, installation & operation for orders received.
18. Vendor must provide hourly rate for installations and must be able to provide bonding when required. Letters showing bonding limits from surety company should be provided.
19. Vendors wishing to submit other services not referenced in this proposal, should qualify their proposals and include additional classifications as a value added service.
